# Second wave of floods hit parts of Hyderabad as rains return

/ A fresh spell of overnight incessant rains caused flooding today in parts of the city and left a girl dead, days after it witnessed one of the worst deluges following the heaviest downpour in over a century, police and civic officials said. The latest rains since Saturday evening led to lakes and other water bodies overflowing and triggering flooding of several low-lying areas, including places affected last week, here and on the outskirts, they said. The Disaster Response Force personnel, the staff of the Greater Hyderabad Municipal Corporation and police swung into action since Saturday night itself, evacuating the marooned. In a near repeat of scenes witnessed last week, basements of several apartment complexes were flooded by the rain waters and people were seen walking in knee deep water in some areas. A video showed some autorickshaws getting washed away in a flooded street. In a rain-related incident, a

Sunday in a wall collapse inMangalhat area here, civic officials said. The Met office forecast more rains in parts of the state till Octo-

At Hayathnagar here, some local residents, including women, confronted local TRS corporator Tirumal Reddy when he visited some flood affected areas on Sunday, accusing him of neglecting their complaints over encroachment of a drain. They said the blockage of the drain resulted in water entering their houses. Heavy rains early last week had wreaked havoc in parts of the state, including the city, claiming over 50 lives in incidents such as house collapse and drowning and leaving hundreds of houses in low-lying areas under sheets of water. The state capital bore the brunt as a depression had dumped the heaviest rains (nearly 20 cm) since 1916 for October on Tuesday and triggered flash floods. The rains abated since Wednesday with the flood water recedgovernment in a preliminary estimate had pegged the losses at over Rs 5,000 crore. However, since Saturday night several parts of the city and neighbouring districts again were battered by torrential rains with Saroornagar in adjoining Rangaraddy district recording the maximum of 16.9 cm while Hyderabad Airport 7.2 cm.

Greater Today, Hyderabad Municipal Corporation (GHMC) Commissioner D S Lokesh Kumar said they launched steps to restore normalcy in the areas affected by the latest spell and intensified relief works. Hyderabad Commissioner of Police Anjani Kumar visited flood-hit localities and said police along with GHMC officials rescued those trapped in their houses and evacuated them to safety. Cyberabad Commissioner of Police VC Sajjanar, also visited different areas and supervised relief works. "DRF working unceasingly to rescue citizens from flooded areas. In-

ing cleared to restore normalcy in the city. Teams working on 24X7 basis in view of the continuing rains. Citizens may dial 040-29555500 for DRF assistance and we will attend asap," tweeted GHMC Vigilance and Disaster Management Director Vishwajit Kampati. The GHMC Commissioner said pumps were being used to drain water from cellars and basements of apartment complexes and other building premises adding civic staff was also clearing stagnated water on roads. A special drive was underway to clear garbage and debris of collapsed houses that had accumulated in drains and on roads. On October 15, the state government had said 50 died due to heavy rains and flash floods. The India Meteorological Department has warned that thunderstorms accompanied by lightning were very likely to occur at isolated places over Telangana and heavy rain is very likely at isolated places from today till

The Ministry of Earth Sciences' Air Quality Early Warning System for Delhi said the ventilation index a product of mixing depth and average wind speed is likely to be 12.500 metre square per second on Sunday favourable for dispersion of pollutants. Mixing depth is the vertical height in which pollutants are suspended in the air. It reduces on cold days with calm wind speed. A ventilation index lower than 6,000 sqm/second, with average wind speed less than 10 kmph, is unfavourable for dispersal of pollutants. It, however, said the impact of stubble burning on Delhi's air quality is likely to increase significantly by Monday. Punjab and Haryana have recorded more incidents of stubble burning this season so far

compared to last year and it is largely due to early harvesting of paddy and unavailability of farm labour due to the coronavirus pandemic, according to officials. The Central Pollution Control Board (CPCB) had Friday said meteorological conditions in Delhi have been "extremely unfavourable" for dispersion of pollutants since this September as compared to last year. With less area under nonbasmati paddy cultivation this time, CPCB Member Secretary Prashant Gargava hoped the number of stubble burning incidents will be fewer this year compared to 2019. Non-basmati paddy straw is considered useless as fodder because of its high silica content and so farmers burn it. Gargava also said stubble burning peak might not coincide with the peak of adverse meteorological conditions this year due to early harvesting of paddy. (PTI)

## With whom BJP siding in Ballia murder case, asks Priyanka



Congress general secretary Priyanka Gandhi Vadra

LUCKNOW/BALLIA, OCT 18 /--/ Congress general secretary Priyanka Gandhi Vadra today asked the BJP whom it is backing in the Ballia murder case where its local party leader allegedly shot a man dead in the presence of an SDM and police three days ago. The incident had taken place on Thursday during a meeting over the allotment of ration shops at Durjanpur village in Ballia's Reoti area. A local BJP leader, Dhirendra Pratap Singh, shot 46-year-old Jai Prakash Pal Gama dead during the meeting. The Uttar Pradesh government had suspended the SDM, circle officer and other policemen present at the spot. Police arrested Dhirendra Pratap Singh and two others in connection with the case on Sunday. So far, eight people have been arrested in the case. Slamming the BJP in a series of tweets, Privanka Gandhi accused a ruling MLA of backing the accused. "With whom the BJP government is siding in the Ballia incident," she asked, adding that the BJP MLA is openly supporting the accused. In another tweet, she sought to know from Prime Minister Narendra Modi, Union Home Minister Amit Shah and BJP national president JP Nadda as to whether they are with the BJP MLA. "If not, then why he is still with the BJP," she asked. Meanwhile, UP's Minister of State for Parliamentary Affairs Anand Swaroop Shukla accused her of dual character. "Priyanka has a dual character. She should have tweeted on senior Congress leader P Chidambaram on the issue of Article 370 in Kashmir. People with dual character are not successful in politics and society," he told reporters here.(PTI)

### Sena welcomes Amit Shah's stand on Maharashtra Guv-CM letter row

MUMBAI, OCT 18 /--/ Shiv Sena MP Sanjay Raut today welcomed Union Home Minister Amit Shah's remark that Maharashtra Governor Bhagat Singh Koshyari could have chosen his words better while writing to Chief Minister Uddhav Thackeray on reopening places of worship in the state. Talking to a TV channel, Raut also said that with Shahs statement, the Shiv Sena has put the issue to rest. Koshyari recently wrote to Thackeray on reopening places of worship in the state and asked if the Shiv Sena president had "suddenly turned secular," triggering a war of words between the governor and the chief minister. Shah on Saturday told a news channel that "Koshyari could have chosen his words better". Reacting to it, Raut said Shah is the country's Home minister and speaks with responsibility and caution. The Rai Bhavan and the office of governor is a constitutional institution and falls under the jurisdiction of the Ministry of Home Affairs, he said. "The governors letter followed by the chief minister's replywas an unavoidable controversy and we havent started it. But, we are satisfied with the Union Home Ministers stand and thank him for understanding the reason of our anger," said Raut. With Shahs statement, the Shiv Sena has put the issue to rest, the party's chief spokesperson said. Raut dismissed speculation that Shah was being soft on the Shiv Sena, a year it snapped its ties with the BJP. "There is nothing political. What Shah spoke was in line with the Constitution of India," he said. On Shahs comments that the case of actor Sushant Singh Raiput's death should have been handed over to the Central Bureau of Investigation (CBI) earlier, Raut asked, "Why should that have been done when the Mumbai Police are capable of probing it?" "Before the investigation was completed, the case went to the CBI.(PTI)

## **UP: BJP workers free** colleague from police custody, party rejects charge they did it forcibly

LAKHIMPUR KHERI, OCT 18 /--/ Unruly scenes were witnessed at a police station here Friday night as local BJP leaders and workers allegedly barged into its premises and freed their colleague detained for misbehaviour with police, but the party denied charges it got

him released forcibly. BJP MLA Lokendra Pratap Singh, who also went to the Mohammadi police station, rejected allegations that his party's Yuva Morcha worker Shibbu Singh was detained for eveteasing, as claimed in some media reports, which were tweeted by Congress leaders Rahul Gandhi and Privanka Gandhi Vadra.

"I will quit as MLA if eve-teasing charges against Shibbu Singh are established. But, if such charges are found baseless, then those levelling false allegations must tender an apology," he told news agency PTI over phone.

It is 100 per cent false, he asserted, when asked about the allegations that BJP workers barged into the police station to free their colleague. No FIR or complaint has been registered against Shibbu Singh his alleged misbehavior with the police, who remained tightlipped over the incident. The MLA said Shibbu

Singh was returning from a party function, which ran till around 10.30-11.00 pm, when he was detained by the police as he was drunk and was put in the lock-up. He said when a senior city leader of the BJP came to know about a party worker being detained, he went to the police station along with our 2-3 workers, who are officer-bearers and requested the inspector to release him if the officer deemed fit. The inspector said that Shibu was mildly drunk. It was no big deal.

I am releasing him', the MLA said. He was released and the matter had ended. I really don't understand where did they get this eveteasing theory from? he asked. If they prove this, I will resign as MLA. And if not proven, then those who are sitting at such high posts and leading a big party should tender an apology and resign. They have made a mountain out of a molehill. It's too shameful, he said. I
